- 3) We purchase Softitech Electronics (Epson projector qty 5 cost 300) on account with landed cost \$5 fright cost, \$5 custom duties from cash on hand.
- 4) We returned to Cimran Electronics 2 Toshiba due to its un usability.
- 5) We purchased from Softitech Electronics HP Laptop core i7, Qty 4, \$300 each paid at Salaam Bank account.
- 6) We refund to Softitech Electronics Qty 2 HP Laptop Core i7.
- 7) Yuusuf sells 2 Toshiba units for \$300 and 1 Epson projector for \$350 (on account), include 5% sales tax.
- 8) Yuusuf has returned to us 1 Toshiba with a problem but no return sales tax.
- 9) Fatima took us to 2 Epson projectors for \$350 each that include with 5% sales tax, and she paid the money; the money was deposited in Dahabshiil Bank and we made discount of \$10 overall order.
- 10) Fatima returned 1 Epson projector with a problem, but no refund sales tax and discount.
- 11) Yuusuf had made payment of the remaining balance to Dahabshiil Bank.
- 12) Cabaas has made a payment of \$250 for his outstanding invoice, and he deposited it in Salaam Bank.
- 13) Paid to Abdirizaq Ali at a salary of \$500 monthly, Mogadishu—Power supply \$100 for Electric expense from cash on hand.
- 14) Billed Office Rent expense \$200 on payable until end of the month.
